Hopefully 2021 will see the return of the Assumption B.V.M. Parish Annual Crafts & Vendors Fair held in conjunction with the Pulaski Polka Days. This will be held July 17th & 18th, 2021 in Pulaski, Wisconsin. This two day, **Saturday & Sunday Crafts & Vendors Fair**, will be open from 9:00 a.m. to 3:00 p.m. We would like to provide an opportunity for people to enjoy browsing and buying your items. Once again, we are giving you the option of **Saturday only or Saturday & Sunday. Sunday only options are available on a limited basis based on available booth sites.**

SPECIAL NOTE: The Friars' property, that has been the site of our past Fairs, has been sold. We are working with the current owners as far as where we can assign booths to vendors. Past booth sites may no longer be available, but we will do our best to assign new booth sites to coincide closely to where you may have been in the past. Parking behind your booth, depending on your location, **WILL BE LIMITED OR UNAVAILABLE** for the 2021 Fair. We will inform you of any changes.

The fee is required with the application and is non-refundable.

All applications must be Postmarked by June 10, 2021. Applications received after June 10th will be put on a waiting list.

We are offering a 12' x 12' outdoor space. Parking **will be limited** for the 2021 Fair **(PLEASE stay within your given booth space – both front/back and side to side) All booths MUST remain at a minimum of six (6) feet from the sidewalk. Once assigned a booth number – You cannot move without Permission.**

IN THE EVENT OF CANCELLATION OF THE FAIR DUE TO COVID RESTRICTIONS, ALL FEES WILL BE RETURNED.

We will not accept unfinished products such as raw wood cutouts.

There is a limited number of crafters/vendors we can accommodate, so return your application soon. Remember to include: (1) your application form (2) fee (3) three photos of your work if you are a new Vendor or if your craft/product has changed since the 2019 Craft Fair and (4) a copy of your Wisconsin Vendors/Sellers Permit. (If you would like your photos returned, please include a self-addressed, stamped envelope.)
